### FINANCIAL AID

All applicants who wish to be considered for federal, state and institutional need-based financial aid must submit the Free Application for Federal Student Aid (**FAFSA**) with a priority date of **October 1** for PA State Grant consideration. International students are ineligible to receive federal or state financial aid.

- ✓ **Personal Essay required for health professions applicants.** No essay required for applicants to other programs. Health professions applicants, please discuss the following:
  - Tell us something unique about you, why you chose your particular major, and how you expect Duquesne University to help you achieve your academic, personal and professional goals. Please include any examples of your research, shadowing or volunteer experiences.

### EARLY ADMISSION APPLICANTS

Exceptional students who wish to enter college prior to high school graduation may apply for Early Admission. The student's first year of college is applied toward the completion of their high school diploma with prior agreement from their school. Early Admission applicants must have a cumulative grade point average (GPA) of 3.5+ and a minimum SAT score of 1260 (EBRW and Math) or ACT score of 26. An **interview** with an admissions counselor, a **personal essay** and **written permission from the applicant's high school principal** are also required. For more details, contact the Admissions Office. Apply by July 1 following your junior year in high school.

### COLLEGE CREDIT IN HIGH SCHOOL (CCHS) APPLICANTS

High school juniors and seniors who wish to take University courses before they graduate from high school will follow the requirements for all applicants, as stated above. Students enrolled in CCHS receive University credit for courses taken. Courses will be offered at a reduced tuition rate. For more details, contact the Admissions Office.

# INSTRUCTIONS FOR INTERNATIONAL APPLICANTS ONLY

## APPLICATION REQUIREMENTS

In addition to the requirements for all applicants, international applicants must submit original or certified copies of academic records from all secondary (high school) and any post-secondary (college/university/institute) schools attended. Copies must be certified by a school or embassy/government official. Transcripts (grade reports) marked "Issued to Student" are not official. All non-English grade reports and documents must be accompanied by certified English translations. International applicants are also required to submit at least one (1) letter of recommendation from someone who can speak to both your academic and personal strengths as well as a personal statement of at least 300 words which answers the following questions and includes any examples of research, shadowing or volunteering experiences: - What is unique about you? - Why have you chosen this major? - How will Duquesne help you to achieve your academic, personal and professional goals?

For transfer students, certified translations of course descriptions must also be submitted.

## ENGLISH LANGUAGE REQUIREMENTS

Students with a first language other than English may begin a full schedule of academic coursework by meeting one of the following standards:

- Obtain a minimum score of score of 70 on the Internet-based TOEFL (or 525 on the Paper-based TOEFL) and a score of 5 out of 6 on the Duquesne University Writing Test
- Obtain a minimum score of score of 6.5 on the IELTS (International English Language Testing Service) and a score of 5 out of 6 on the Duquesne University Writing Test
- Obtain a minimum score of score of 100 on the Accuplacer (with no sub-score lower than 85) or 70 on the Michigan EPT (English Placement Test) administered at Duquesne University, and a score of 5 out of 6 on the Duquesne University Writing Test
- Compete all ESL courses and language testing requirements at Duquesne University with passing grades and satisfactory scores.

Students may enroll in partial academic classes and partial ESL classes, as assigned by their ESL advisor, by meeting one of the following standards:

- Obtain a minimum score of score of 60 on the Internet-based TOEFL (or 500 on the Paper-based TOEFL) and a score of 4.5 out of 6 on the Duquesne University Writing Test
- Obtain a minimum score of score of 6 on the IELTS (International English Language Testing Service) and a score of 4.5 out of 6 on the Duquesne University Writing Test
- Obtain a minimum score of score of 90 on the Accuplacer (with no subscore lower than 80) 65 on the Michigan EPT (English Placement Test) administered at Duquesne University and a score of 4.5 out of 6 on the Duquesne University Writing Test

**Students who are accepted into Duquesne University undergraduate programs and do not meet the standards listed above for will be enrolled in the ESL program until their language proficiency is sufficient to begin academic work.**

## FINANCIAL INFORMATION

2. International applicants must also submit documents certifying availability of adequate financial resources. 3. **Libermann Scholarship Information:** International applicants may be considered for partial-tuition scholarships offered through the Office of International Programs. Scholarships are awarded according to academic merit and are applicable to tuition costs only.
